- h. Will not operate the craft with more people than are listed on the rental agreement.
- i. Will report all defects in the craft or equipment to lessor at the earliest possible moment.
- j. Agrees that lessor shall be held liable for any inconvenience or time lost caused by an accident, breakdown, or malfunction of rental equipment.
- k. Agrees that lessor shall be held harmless of, from , or against any and all costs, damages, attorney's fees and/or other liability associated with lessee actions connected with this rental agreement and with any damages occurring during this rental agreement, including injury to other persons (including death), property, lessee's property.
- l. Agrees to hold lessor harmless of any cost of enforcing this agreement and that venue of action will be in the county of the lessor.
- m. Agrees that lessor may cancel this agreement at any time for just cause such as inclement weather or unsafe action by lessee.
- n. Early return of rental boat will not result in a refund.
- o. No one under the age of 22 years old will be allowed to drive the boat.**
